



This month IEEP presented [a future vision on transforming EU land use and the Common Agricultural Policy \(CAP\)](#) in an open and fruitful dialogue at a dedicated event with think tanks, policy makers, farming organisations, NGOs, and private sector representatives.

IEEP's new vision calls for deeper changes to the CAP and the EU budget, which has not delivered sufficient action to date. In the coming decade, EU support for farmers and land managers needs to focus on aid for a fair transition, financing for environmental services, funding for advice and training, and investment in innovation and research. Due to the lock ins and path dependencies in the CAP, our paper puts forward the option of creating new sustainable land management and fair transition fund in the post-2027 EU budget to drive a transition, overseen by climate and environmental authorities. This would be funded by a combination of transfers from the CAP and other funding sources, and operate alongside a 'slimmed down' more targeted version of the CAP.
