About the event

The focus of this lunch briefing will be on the announced Action Plan for Affordable Energy Prices, part of the Clean Industrial Deal framework, and the pending Energy Taxation Directive. The new Commission presented the Clean Industrial Deal at the end of the first 100 days from the beginning of its mandate, as a growth strategy that brings together the challenge of the climate crisis and competitiveness concerns for energy-intensive industries and the clean tech sector. As a consequence, renewable energies should feature as major component of the transition to boost EU industries' competitiveness. The briefing will be organised around the following questions:

- After the reform of its electricity and gas markets, is the EU prepared for a potential energy price crisis?
- How can the EU quickly mobilise its own low-cost clean energy sources for both its citizens and businesses?
- Can the EU afford price caps? (Pros and cons of different forms of intervening in energy markets)
- How to balance industries' and consumer groups' needs for support and protection?
- How to promote energy savings and demand-side flexibility to lower household bills and make industries competitive?
